IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER Monitoring Requirements Not Met for SPERRY PWSID#OK3007202

Our water system violated a drinking water standard over the past year. Even though this was not an emergency, as our customers, you have a right to know what happened and what we did to correct the situation.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During September 2015 we **did not properly monitor** for bacteriological contaminants and chlorine residual. Therefore, we cannot be sure of the quality of our drinking water during that time.

What should I do?

There is nothing you need to do at this time.

The table below lists the contaminant we did not properly test for during the last month, how often we are supposed to sample for this contaminated and a samples we are supposed to take, how many samples we took, when samples should have been taken, and the date on which follow-up samples were or will be taken.

Bacteriological	2/Month	0	Sept 2015	Oct 2015

The sample that was missed in the month of September 2015 was taken October 5, 2015. That sample did not have any bacteriological contaminants.
