Kimberly Johnson has been promoted to Chief Operating Officer for the Tulsa City-County Library.

In this role she will develop and implement long-range plans for services and operations, execute the 2030 Facilities Master Plan, and lead the public service side of the Central Library renovation project.



Johnson, originally from the Bronx borough of New York, earned her Bachelor of Arts from the University of Tulsa and earned her Master of Library and Information Science from the University of Oklahoma.

She joined the Tulsa City-County Library in 1998 as the first coordinator of the African-American Resource Center. In that role she was responsible for collecting, preserving and providing access to resources honoring and documenting the experiences of people of African descent. She established the library's first countywide public tour to Oklahoma's Historic All-Black Towns as well as Tulsa's first countywide reading initiative, "Tulsa Metro Reads."

In 2005, she was promoted as the manager of the South Broken Arrow Library followed by a promotion in 2010 as the manager of Hardesty Regional Library. In 2012, she was ed to Regional Director with responsi-1 of the Tulsa City-County Library's public locations. American driving habits are being analyzed through a AAA study.

The study shows that Americans drive an average of 29.2 miles per day, making two trips with an average total duration of 46 minutes.

This and other revealing data are the result of a ground-breaking study currently underway by the AAA Foundation for Traffic Safety and the Urban Institute.

The Foundation's new American Driving Survey offers the most up-to-date, comprehensive look at how much Americano unire on a dany and yea

First-year data, collected May 2013 through May 2014, is available now from the ongoing study, which will set the benchmark for future data and ultimately reveal trends in Americans' driving hab-

"This is the first ongoing study that provides a look at when and how much Americans are driving," said Peter Kissinger, President and CEO of the AAA Foundation for Traffic Safety. "Existing federal data with this level of detail was last released in 2009, eight years after the previous release. This substantially limits the extent to which we can use existing cans' current driving habits."

The first-year results of the American Driving Survey revealed that:

- Motorists age 16 years and older drive, on average, 29.2 miles per day or 10,658 miles per year.
- · Women take more driving trips, but men spend 25 percent more time behind the wheel and drive 35 percent more miles than women.
- · Both teenagers and seniors over the age of 75 drive less than any other age group; motorists 30-49 years old drive an

Yet studies show that only 20 percent of the civil legal needs of the poor are being met. Pro bono attorneys are often the only source of hope for those who can't afford to hire a lawyer.

Through ProBono.Net/OK, Oklahoma lawyers can access a wealth of resources to assist their representation of low-income Oklahomans with civil legal problems," Figgins said. "Legal Aid relies on the many Oklahoma lawyers who regularly give back to their communities by assisting individuals with civil legal problems, free of charge, to leverage our precious resources and increase the number of people we can serve.
